The purpose is:

- Strengthening police cooperation (operational information exchange) between Romania and Ukraine, with emphasis on preventing and combating organized crime, through a cooperation-based IT system supported by modern facilities;
- Increasing operational and technical capacity for the police structures on both sides of the border for the provision of specific services.

Project outcomes

760 participants involved in joint capacity building activities (exchanges of experience, study visits, trainings etc)

78 modernized facilities of police, police border and custom services from the eligible area

1 Functioning cross-border collaborative IT platform

Approx. level of information exchanged between the police services in cross-border region in the last year of the project implementation

compared to the yearly average of the 3 years before the start of the project- **80%**

Approx. level of time reduction of information exchanged between the police services in cross-border region in the last year of the project implementation compared to the yearly average of the 3 years before the start of the project- **50%**

Level of the positive reactions/letters or electronic messages compared to the yearly average of 3 years before the start of the project- **50%.**

Target groups and final beneficiaries

400 Romanian Police Officers from Maramureş, Satu Mare, Botoşani, Suceava counties, 200 Romanian Border Police Officers from Maramureş, Satu Mare, Botoşani, Suceava counties, 160 Ukrainian Police Officers/ Ukrainian Border Guard Service officers /law enforcement officers from Ivano - Frankivsk region and other eligible area of the programme **have participated to the project activities.**

6,200 Romanian and Ukrainian Police officers and Border Police officers from Maramureş, Satu Mare, Botoşani, Suceava counties and Ivano - Frankivsk region and other eligible area of the programme **will benefit from the project results on the long term.**
