The Managing Authority for Romania-Ukraine Joint Operational Programme 2014-2020 has started the process of preparing Interreg NEXT Romania-Ukraine Programme for 2021-2027

In June 2020, the Joint Programming Committee was set up. This is the main body to decide on the programming process and it is formed of representatives of public central and local authorities, as well as other stakeholders from both partner countries. The representativeness of the Joint Programming Committee is available <u>here</u>.

Up to date, there have been taken decisions regarding the working procedure of the Committee, preparation of the documentation for strategic environmental assessment and settling the programming area. The programme area covers 5 counties in Romania, i.e. Satu Mare, Maramureş, Suceava, Botoşani, Tulcea, and Zakarpatska, Ivano-Frankivsk, Chernivtsi, and Odessa oblasts in Ukraine.

The Joint Programming Committee approved the methodology of drafting the future programme and it decided to start the territorial analysis stage. The programme drafting methodology is based on the European draft regulations which are under approval, and on TESIM guidelines available for all programmes, which can be found here. During the programming process, local and national stakeholders will be consulted (public local and national authorities, NGOs etc.), both on drafting the territorial analysis, as well as on establishing programme priorities, target groups and potential beneficiaries, and on identifying large infrastructure projects to be implemented in partnership, so as to answer to common needs.

Furthermore, the public will be asked to send proposals on the draft of the programme, which will be published on this page of www.ro-ua.net, as well as on www.mlpda.ro (Ministry of Public Works, Development and Administration in Romania) and on the website of the Cabinet of Ministers in Ukraine.

#### RO-UA 2014-2020 - Perspectives and results

The tangible results of the projects financed by the European Union through the Joint Operational Programme Romania-Ukraine 2014-2020 are not long in coming, demonstrating the usefulness of the chosen priorities. Joint actions and research studies (including the purchase of related equipment) in the field of environment (challenges related to climate change, biodiversity conservation, renewable energy and resource efficiency) have reached a common denominator in the project "Promoting dead wood to increase forest resilience in Romania-Ukraine cross-border area" RESFOR, 2SOFT / 1.2 / 13. the project has a duration of 18 months (January 2020 - June 2021). The specific objectives, activities and expected results of the project are related to the target area of the project in Romania (Maramures and Suceava counties) and Ukraine (Ivano Frankivsk and Zakarpattia regions). Dead wood (standing dead trees as well as fallen logs) is a critical component in the structure and functioning of the forest, playing a key role in maintaining its productivity, natural regeneration, biodiversity conservation, increasing resilience to climate change. On the other hand, the presence of dead wood contributes to the provision of valuable ecosystem services to local communities and the general public. In the following, we present you the steps taken so far by the beneficiaries of our programme, towards a successful result.

Dead wood is the richest habitat in a healthy forest



Old tree trunks, trees that are dying or are already dead, tree trunks and fallen branches form one of the richest and, so underestimated habitats far. for biodiversity in Europe. Deadwood plays a key role in maintaining forest productivity, natural regeneration, biodiversity conservation, and increasing resilience against the climate change. However, deadwood management is a relatively new concept in Romania and Ukraine that has only been promoted since the 2000s. Dead or

fallen trees provide the habitat of about 30% of insects living in the forest, they can be home to various species of birds and mammals, they accumulate carbon from the atmosphere through the food chain and their decomposition is a source of increased soil fertility.

As part of the RESFOR project, Ukrainian and Romanian scientists are exploring the benefits of increasing the amount of deadwood in the forest to increase the resilience of forest ecosystems. The partners in the project are environmental organizations WWF-Romania and the Ukrainian NGO "Ecosphera", as well as scientific institutions such as the Ukrainian Research Institute of Mountain

Forestry named after P.S. Pasternak - UkrRIMF in Ivano-Frankivsk - Ukraine, and the "Stefan cel Mare University" of Suceava in Romania. To date, UkrRIMF scientists have established 20 circular sample plots with an area of 500 m2 each in the forest of the Drestunka Velyka river watershed, which is located in the Krasnytsia forestry unit of the Verkhovynske State Forestry Enterprise in Prykarpattia in managed forests. At the sample plots, a complete description and assessment was performed, the height and diameter of the trunk of each tree were



measured, the cores were drilled, and the amount of deadwood on the transects was determined.



"Biodiversity assessment was performed at 4 1x1 m sampling sites, which are located at a distance of 6.31 m from the sample plot center on 4 cardinal directions (N, E, S, W). Due to the end of the vegetation season, the diversity of herbal layer is low. We found Galeobdolon luteum, wood sorrel, lady fern, hedge bedstraw, mosses. After processing the field data, we plan to show the difference in phytodiversity depending on the structure of the stand and fellings that was carried out there, "explains Ivanna Danilova, a junior researcher at UkrRIMF.

""We assessed lying and standing deadwood. The assessment of standing deadwood was carried out within the assessment of the stand on the sample plot. For each tree, the diameter of the trunk at a height of 1.3 m, the stage of decomposition and the corresponding code (according to the agreed methodology) were indicated", adds the senior researcher of the UkrRIMF, Ph.D. Taras Yunyk. And he continues: "We described also each part of lying deadwood within each sample plot to show it later on a 3D model".

Transect assessment was performed to calculate the volume of deadwood on each according to the formula of Bohl and Brandi. Within the project, it is planned to establish 20 more sample plots in virgin forests.

The emphasis of research on the deadwood role in the resilience of forest ecosystems against climatic conditions is given to dendrochronology. For this purpose, mostly older trees of typical Carpathian species spruce, beech, fir - were selected to take wood cores. "We expect to identify cyclical links between annual ring width and meteorological factors - temperature,



humidity - over the past 40-60 years, or to identify the impact of stand structure on tree growth during ontogenesis", explains Ph.D. Taras Parpan, leading researcher at the UkrRIMF.

Similar studies are being conducted by Romanian colleagues at the University of Suceava in the Romanian Carpathians. Last month a research team from the Laboratory of Forest Biometry performed inventory activities in the virgin forest of Strâmbu Băiuț in the Maramures County. Field data







collection was done based on the same detailed protocol used by Ukrainian colleagues and elaborated

under the RESFOR transboundary project. The main focus of this research activity has been to understand in detail how virgin forests are structured and organized as well as the quantity of deadwood that characterizes such forests, to assess the decaying level of deadwood as well as specific biodiversity, and to measure disturbancies associated with as well as the resilience of natural forests to climate changes. The same inventory activity will be performed in production forests next to Strâmbu Băiuţ. The first scientific comparative results, between natural and managed forests both in Ukraine and Romania, can be expected in the beginning of 2021 and will be used for the elaboration of best practices for sustainable deadwood management in order to improve production forests resilience to climate changes as well as the benefits they provide to local communities.



## Autumn recap within the Romania - Ukraine Programme 2014-2020 Safe cooperation for a whole month!

The echoes of the cooperation flowed throughout the autumn within the context of the Romania-Ukraine programme 2014-2020, for a whole month, between September 21 and October 20 a.c. The extensive campaign of celebrating European Cooperation Day, took place under the slogan "Safely, together!".

European Cooperation Day is celebrated every year on 21 September. The opportunity of this celebration is given by the mixture of cultures and economies that defines Europe, a diverse community that must understand each other to reach its full potential. The European Union encourages cooperation in various ways. One of them is through cooperation programmes, which allocate more than 10 billion euros for regions to work together on common challenges: climate adaptation, social inclusion, migration and more. How is this done in practice? Through projects involving regions throughout the European Union and neighboring countries. They have contributed to increasing cultural understanding and overcoming economic disparities in all territories. And this is a good reason to celebrate.

The "European Cooperation Day" campaigns aim to bring to the attention of citizens the fact that many good things happen when we join our forces. In the past editions, people have donated blood, ridden bicycles, sung together, eaten together and generally had great fun in each other's company, in hundreds of events organized by EU cooperation programmes in over 30 of countries. In September and October 2020, numerous events were organized in different regions of Europe to mark the benefits of cooperation: film festivals, conferences, competitions and many other actions, mainly online, adapted to the current health crisis. In Romania and Ukraine, the Joint Operational Program Romania - Ukraine 2014-2020 carried out the European Cooperation Day on three levels: cooperation, digitization and security. Between September 21 and October 20, 2020, residents of counties on the border with Ukraine were invited on a safe



journey "Safely, together!" through Tulcea, Botoşani, Suceava, Baia Mare or Satu Mare, with public transport that popularized the message of the Romania - Ukraine Programme for European Cooperation Day. The European Cooperation Day was present in Ukraine online, through a campaign to promote cross-border cooperation and partnerships that generate results and solutions to common problems of both countries. Last but not least, campaigns for the distribution of protective masks were further conducted in each of the 5 Romanian cities in the Program area. In order to ensure a safe journey in the campaign buses, information packages containing disposable protective masks were distributed in the bus stops on the routes on which the personalized means of transport circulated.

The beneficiaries of the Romania-Ukraine Programme also marked the Cooperation Day - "Safely, together!" through various events and activities carried out both in Romania and in Ukraine.

These include numerous international webinars. creating a network of RO-UA beneficiaries involved in education projects, outdoor actions on prevention led by law enforcement involved in the program, exhibitions of painting, photographic art and drawing and, of course, the events of the Ukrainian partners, such as the "European Book Month", the "Europe exhibition seen through the eyes of Ukrainian artists", flashmobs or cycling competition.



The cooperation was celebrated online also in Tulcea county through the JERAD project (JOINT EMERGENCY RESPONSE ACROSS DANUBE) 2SOFT4.2 / 70. They held a dedicated webinar on September 30th. The project teams of the two partners participated along with the monitoring and implementation officer within BRCT Suceava and the legal representatives of the two partner structures. The guests mentioned in their interventions the





importance of cross-border cooperation and the benefits that European-funded projects bring to our communities. It was also emphasized that this project is the beginning of a long-term cooperation between the Inspectorate for Emergency Situations Delta of Tulcea County and the State Department for Emergency Situations of Odessa Region in order to increase resilience and protection of communities in the two regions against natural disasters as well as for the development of the intervention capacity of the professional structures

European Cooperation Day was marked in Satu Mare by organizing, on October 12, a joint event of member institutions in the County Commission for Preventive Activities, Monitoring an event coordinated by the Satu Mare County Police Inspectorate, beneficiary of the LIP 4.3 project Regional Cooperation for Prevention and Fighting of Cross-border Crime between Romania-Ukraine -SAGA. Carried out in the Negresti Oas Village Museum - OSANUL, in open air, hosted by the students of the Negresti Oas Theoretical High School, coordinated by the principal, the school

psychologist and the teachers, the representatives of the Satu Mare County Police Inspectorate, the

Satu Mare Drug use Prevention, the Satu Mare County Gendarme Inspectorate, the Satu Mare Border Police Territorial Service and the National Agency Against HumanTrafficking, Oradea Regional Center -all organized an informative activity focused on the field of prevention of victimization of minors, in the context of European Cooperation Day.

The presentation made by the police officers from the Satu Mare County Police Inspectorate aiming at European cooperation, the film of the "Be free" campaign of the Satu Mare Anti-Drug Center, but



also the online interventions of Oradea speakers caught the attention of young high school students, preventive messages regarding student safety in school, in the circle of friends, in the community, but also abroad, being shared using applied examples. The exhibition with the works of the students of



the Art High School "Aurel Popp" Satu Mare containing painting, photographic art and drawing on various topics delighted the participants, facilitating communication with representatives of institutions present, having the opportunity to answer questions from young people about the topics presented through thematic presentations and films.

Masks were also distributed to the participants, the activity being carried out in compliance with the prevention measures to stop the spread of COVID.


The presence of so many institutions at the event is a clear proof of the existing cooperation

The European Day of Cooperation was also celebrated in Maramureş, in Sighetu Marmatiei, in a large event organized by the Municipal Hospital, which is currently implementing 4 cross-border projects with partners in Ukraine, including one with the local council Solotvyno, which aims to rehabilitate three buildings and the purchase of medical equipment for services at the highest level. At the same time, seminars will be organized so that hospital staff can enhance cooperation and improve its skills. The celebration was attended by the project team, local council specialists and representatives of institutions implementing cross-border projects.








**EUROPEAN** Suceava, during the In COOPERATION DAY 2020, the "Stefan cel Mare" University (USV) in partnership with the Odessa National Polytechnic University (ONPU) and the Ivano-Frankivsk National University of Oil Technical and Gas (IFNTUOG) organized not one, but 3 events (online). Starting from the idea that in an atypical context, generated by the pandemic, we must keep close the relations we have with our neighbors and develop the opportunities created by these border regions close to us, the UNIV.E.R-U team considered that a good step in this direction could be a webinar.

Entitled #CROSSBORDERCOOPERATION, the webinar was moderated by Marcela Şlusarciuc, coordinator of the UNIV.E.R-U Project, Lecturer PhD within USV, in the presence of Professor PhD Ştefan Purici, Vice-Rector of USV and project manager within UNIV.E.R-U Project and Mykhailo Lebid and Nataliia Lebid, representatives of ONPU. The guest speaker of the webinar that attracted over 60

participants, was Cezar Grozavu, Executive Director at Regional Office for Cross Border Cooperation Suceava. He addressed to students from USV and ONPU that attended the event via Google Meet, and told about cross-border cooperation and its importance in developing partnerships and projects that improve life in the area. The event also benefited of a Q&A section where students both from Suceava and from Odessa express their ideas or concerns regarding the outputs of CBC projects conducted by their universities in the context of the pandemic. The second event, Beyond the borders: words from



images (stories competition starting from images) – October 16th, 2020 showed that stories are meaningful to all of us. Using a set of representative images for the areas targeted by the cross-border projects, 6 teams of students from three universities partners in CBC projects, were challenged, during the event, to compose an essay or a story. The random choice of images allowed the more than 30 participating students to extend the limits of their creativity, encouraging originality, and arousing



curiosity in knowing the "cross-border territories". The presentation of the creative products connected the teams (Carpathian Adventures, Dream Team, ONPU The Best Team, Travelers Team, Omni Travelers and Borderlinks) with the other participants and with the audience. The event was facilitated by Marcela Slusarciuc, coordinator of the UNIV.E.R-U Project, and the jury was formed from representatives of two CBC Development projects, of cross-border cooperation in promoting objects of historical and cultural heritage in the cross-border territory of Romania and Ukraine - HE-CROSS and Educational University Romanian-Ukrainian

*Cross-Border Cooperation – UNIV.E.R-U*, respectively Prof. Ludmila Archipova ("Ivano-Frankivsk" National Technical University of Oil and Gas), Prof. Harieta Sabol ("Stefan cel Mare" University Suceava) and Prof. Nataliia Lebid (Odessa National Polytechnic University).

European Cooperation Day was the crucible that led to the creation of a Communication Platform for cross-border educational projects, opened during the third event held on 19 October. Representatives of cross border educational projects financed by Joint Operational Programme Romania–Ukraine 2014-2020 from Suceava, Baia Mare, Botoşani, and Chernivtsy met online and presented the projects

they conduct, in the presence of Cezar Grozavu, Executive Director at Regional Office for Cross Border Cooperation Suceava. Goals, expected results or examples of activities, were presented during the meeting and the participants used this opportunity to connect and to find the potential for new cross border educational projects, as first step for capitalization. Topics such as common challenges or unknown aspects of the legislation of the two countries were debated and representatives of several CBC projects present at the meeting concluded that the creation of a formal or informal network is welcome and most needed



in the future. The event was moderated by Marcela Şlusarciuc, Project coordinator.
